- 1. Sources of Muslim Law One Week
  This will cover the primary and the secondary sources of Muslim Law
- 2. Schools of Muslim Law One Week
  This will cover the two major sects of Muslim Law i.e. Sunni and Shia and their subdivisions of schools
- 3. Dower One Week
  - This module will deal with the concept, explanation, types and importance of dower or mehr in a Muslim marriage
- 4. Marriage in Muslim Law One Week
  This module will deal with the object, types, capacity, essentials and disabilities of
  - marriage. The concept of Muta marriage will also be dealt under this module.
- 5. Dissolution of marriage One Week
  - This module will deal with the ways of dissolution of marriage, types of divorce and the constitutionality of the Talaq-ul-Biddat. It will also deal with the grounds of divorce available to a woman under the Dissolution of Muslim Marriage Act, 1939.
- 6. Maintenance One Week
